

GULFPORT FLOCK SHARED NETWORKS - READABLE SUMMARY

Comparison of the June 15, 2026 XLSX export and August 26, 2026 CSV export

Important: This is a readability aid derived only from the two produced SharedNetworks files. It is not a substitute for the original XLSX/CSV records. The original files should be published alongside this PDF.

What the files contain

Both files use the same three columns: **Organization Name**, **Networks Shared With Me**, and **Networks I'm Sharing**. The files themselves do not define those fields further, so this summary preserves the column labels without adding an interpretation that is not stated in the records.

Comparison between the two snapshots

The June file contains **1,516** organizations and the August file contains **200**. **194** organization names appear in both files. **1,322** appear in June but not August, while **6** appear in August but not June.

That large difference means the two files should be treated as separate snapshots rather than interchangeable copies. The records alone do not establish why the scope changed between June and August.
